Campus, Dr. Giridhar Rao Road, Kodialbail, Mangaluru 575003, Karnataka, to start new Ayurved Medical College in the name of "Sharada Ayurveda Medical College and Hospital, Devinagar, Talapady, Mangaluru, Karnataka" with 60 seats in UG (BAMS) Course, from the academic session 2019-20, under Section 13A of the IMCC Act, 1970 - Permission Letter-reg.

Sir.

In compliance of Hon'ble High Court of Karnataka at Bengaluru in W.P. (C) No. 30984-30985 of 2018, Ministry forwarded your application dated nil to the CCIM vide its letter of even number dated 21/12/2018, for further examination and necessary action as per the provisions of the IMCC Act 1970 and the relevant regulations.

- 2. CCIM visited the college on 06.02.2019, and issued Letter of Intent to you vide their letter No. 04-170/2019-Ay.(NP) dated 12.04.2019 and vide Corrigendum of even number dated 19.06.2019, to establish a new Ayurveda Medical college in the name of "Sharada Ayurveda Medical College and Hospital, Devinagar, Talapady Mangaluru, Karnataka" with 60 seats in UG (BAMS) course from the academic session 2019-20 under section 13A of the IMCC Act, 1970.
- 3. The CCIM had carried out an inspection of the institution again on 22-23.05.2019, to assess the available facilities of teaching and practical training for conducting UG (BAMS) course and to verify the compliance of shortcomings informed by the CCIM under section 13A of IMCC Act, 1970 and forwarded its recommendations and report to the Ministry. On examining the same, certain deficiencies have been observed and therefore, under provisions of the first proviso to sub-section (5) of Section 13A

of the IMCC Act, 1970, an opportunity of hearing was granted to the college on 05.07.2019 to present their case.

- 4. The observations of hearing committee based on submission made by the college representatives during hearing and recommendations & visitation report of the CCIM have been carefully examined in terms of Regulation 3 and 10 of the "Indian Medicine Central Council (Requirements of Minimum Standard for under-graduate Ayurveda Colleges and attached Hospitals) Regulations, 2016", provisions under the IMCC Act, 1970, relevant regulations made there-under and as per approved Standard Operative Procedures (SOPs), it was found that the College is not fulfilling notified and approved criterion for issuing Letter of Permission for conducting UG (BAMS) course from the academic session 2019-20. Hence, Ministry, vide its order of even number dated 19/07/2019, issued denial of permission to start new Ayurveda Medical College, in the name of "Sharada Ayurveda Medical College and Hospital, Devinagar, Talapady Mangaluru, Karnataka" with 60 seats in UG (BAMS) course from the academic session 2019-20.
- Subsequently, the CCIM, vide its letter No. 04-170/2019-Ay.(NP) dated 27.08.2019, has sent a clarification regarding the deficiencies mentioned in the denial letter of permission issued by the Ministry vide its order dated 19/07/2019, which was examined in terms of Regulation 3 and 10 of the "Indian Medicine Central Council (Requirements of Minimum Standard for under-graduate Ayurveda Colleges and attached Hospitals) Regulations, 2016", provisions under the IMCC Act, 1970, relevant regulations made there-under and as per approved Standard Operative Procedures (SOPs), it was found that the College is now fulfilling notified and approved criterion for issuing Letter of Permission for conducting 60 seats in UG (BAMS) course from the academic session 2019-20.
- 6. It has, therefore, been decided by the Central Government to issue Letter of Permission to the President, Tulunadu Educational Trust (Regd.) S.K.D.B. Campus, Dr. Giridhar Rao Road, Kodialbail, Mangaluru 575003, Karnataka to start new Ayurved Medical College in the name of "Sharada Ayurveda Medical College and Hospital, Devinagar, Talapady, Mangaluru, Karnataka" with 60 seats in UG (BAMS) Course, from the academic session 2019-20 under section 13A of the IMCC Act, 1970, subject to following conditions:
  - i. The college shall submit an undertaking in form of affidavit duly notarized within one month from the date of issue of the letter, explaining the details of providing EPF and ESI facilities to the teaching, non-teaching staff of the Colleges/Hospitals and regularly paying the same as per the provisions of Employees' Provident Funds and Miscellaneous Provident Act, 1952 & ESI Act, 1948 and relevant Rules and Regulations.
  - ii. The colleges shall submit undertaking in the form of Affidavit duly notarized to get permanent registration of the Teachers/Hospital Clinical Staff/Consultant in concerned State Boards/Council where the college/hospital is located or Central Registration of the CCIM by 31st December, 2019 as per the decisions conveyed vide letters 12.04.2019 & 19.06.2019 by CCIM and decided by the High Court of Karnataka at Bengaluru W.P. No. 30984-30985 of 2018, which will be verified by the Council during next visitation while considering the matter for grant/denial of permission for the academic year 2020-21.

- 7. It is further informed that 15% of undergraduate seats of the permitted intake capacity of 60 UG seats shall be treated as all India quota. The counseling for seats under all India quotas shall be conducted by the Central Government and counseling for the remaining 85% seats shall be conducted by the concerned Counseling Authority of that State. If any seats are not filled up in the Central Counseling, the same shall be transferred to the said Counseling Authority to admit students as per their rules/ reservation policies/norms. The permission of the college stands withdrawn if the college fails to comply with the Central counseling for all India quota or the students admitted thereunder.
- 8. Admissions made in violation of the above conditions will be treated as invalid and action will be initiated under IMCC Act & Regulations made thereunder.
- 9. Discrepancies, if any, may be immediately brought to the notice of CCIM and the Central Government.
- 10. The following requirements should be fulfilled by the college by 31<sup>st</sup> December, 2019 to get permission for the session 2020-21:
  - (i) all the Requirements of Minimum Standard of infrastructure and teaching & training facilities as specified in Regulation 3 and 10 of the "Indian Medicine Central Council (Requirements of Minimum Standard for under-graduate Ayurveda Colleges and attached Hospitals) Regulations, 2016;
  - (ii) all the requirements of the Indian Medicine Central Council (Minimum Standards of Education in Indian Medicine) Amendment Regulations, 2016 (for Ayurveda); and
  - (iii) all the requirements under the provisions of the IMCC Act, 1970 and relevant Regulations made thereunder should be fulfilled *in toto*
- 11. The college administration will ensure that sufficient qualified teachers and non-teaching staff in the college and requisite staff in the hospital, as per the relevant CCIM Regulations, are in position before the admission of the first batch of students in the 1<sup>st</sup> professional of BAMS course is made, under intimation to the Central Government and CCIM.
- 12. The college has to develop the requisite infrastructure for II<sup>nd</sup>, III<sup>rd</sup> and IV<sup>th</sup> professionals well in time as per the CCIM norms which will be verified and reported by the CCIM at least three months before the start of next professional and accordingly, the permission for taking admissions in subsequent academic session will be issued.
- 13. The college administration may take up the matter for recognition of the qualification under section 14(2) of the IMCC Act, 1970 at that time when the first batch of students admitted against this course appears for the first final professional examination of the said course.
- 14. The fulfillment of the conditions given above may be made within the time period specified and compliance report should be submitted by the college to CCIM under intimation to this Ministry. The CCIM will verify that the conditions have been fulfilled by means of an inspection and submit a report along with its assessment in this matter to the Ministry of AYUSH for considering the permission matter from the academic session 2020-21.
